Over the course of the six weeks, players will learn the correct techniques in hitting for power and success at the plate. Additionally, those wishing to learn slap hitting will be offered that as well. Our techniques are well proven with placing many players at the college level from Division I through Division III as well as producing some of the area's top high-school players. Included in this will also be a Right View Pro Video Analysis of each player's swing.
